

## THE 1959 SEASON

By MAURICE B. RECKITT

Now are the seasons of our discontent Made glorious summer by this sun of heaven.

THOUGH no doubt we have not done justice to Shakespeare in the above, one feels that it is only such a master of our language who could do justice to the five months of weather which croquet players have experienced this year. Few of them can ever remember a season like it, for not many of us were free to play the game at all in 1940; only a handful can recall the summer of 1921; and fewer still that of 1911, when a shade temperature of 100 degrees was experienced during the week of the first Ladies' Field Cup and the Manager (Col. Brooke) withdrew his charges from the courts for a whole afternoon, the menace of sunstroke having become an occupational hazard. By the Thursday of the Peels this year the temperature had risen to 71 degrees; on the second Wednesday at Devonshire Park it was 74 degrees, and week after week with similar figures stretched between. For what we have received this season we must be—as surely we are—truly thankful.

If the weather was this summer's most spectacular characteristic, a more strictly croquetical one is scarcely less memorable. This is the remarkable record of our greatest player, John Solomon. Competing successively in the Men's Championship, the Open Championship, the Doubles Championship (with Patrick Cotter), the Opens at Hurlingham and the President's Cup, he won all of these premier contests, a record which could not be surpassed and has never, one believes, been precisely equalled. Having spoken of John as our greatest player, this chronicler, with fifty years' experience of the game, will go a step further and venture the claim that he is in fact the greatest player of all time, in this country at any rate. When one recalls the great names of the past this may appear to be a temerarious judgment, and in any case comparisons in such a matter can never be satisfactorily established. But the temptation to make this one is to me irresistible.

In the face of such a record as this not much scope was left to John's rivals. One is reminded of Lewis Carroll's hippopotamus:

... descending from a bus; ... if he should come to tea, I said, there won't be much for us.

Perhaps the "rankings" at the end of the President's Cup can be taken as fairly representing the next three placings. Humphrey Hicks was not only a good second in this event but the runner-up in the Open Championship and the winner of the Sussex Cup at Brighton. Patrick Cotter had one of his less successful seasons, but even when things are not going his way he never looks anything but the masterly player we all know him to be. William Ormerod could play only in the Open Championship and the President's Cup, but lack of practice seems in no way to impair the immense effectiveness of his game. Yet one may respectfully question whether his increasingly loosely-knit methods of "boosted" hoop and long roquet can ever produce croquet of the very highest class. No one could fairly describe his game as "hit and miss" since in fact William scarcely ever does miss, but if balls are to be spread thus over so wide an area of the court something of the precision necessary to perfection is inevitably sacrificed.

It was unfortunate that a miscalculation prevented Dr. Wiggins from competing with his peers in the Best Eight, for this is an event in which he generally appears to advantage. It was he who deprived Cotter of his title in the Open Championship, and he subsequently played three good games with Ormerod. At Hurlingham he fell to Brian Lloyd-Pratt whose game made the advance which all good judges had confidently predicted would be the case, despite his having less opportunities for play than was the case last year. Once he had mastered the narrow hoops in the President's Cup he looked equal to beating anyone, and he has surely established a secure position in this event for a long time to come. Tied with him at the end of the competition was Dudley Hamilton-Miller, whose return to the game was one of the happiest features of the season. How pleasant it was for those who remember that controlled and leisurely swing from earlier days to see it once more in action on the courts, to welcome back to our midst a former captain of England, and to salute a new South of England champion.

Mrs. Rotherham's play during the season was as successful as it was indefatigable and won for her the merited distinction of the "basic" handicap of minus three. She came nearer than anyone else to inflicting (at Hurlingham) a defeat upon John Solomon, and her beautifully accurate breaks and fine shooting meant that she was always likely to be in the hunt even against the strongest opposition. But one trophy which might almost have seemed to belong to her of right in fact eluded her, for it was Miss Warwick who carried off the Ladies' Field Cup. This lady's advance was very marked, especially perhaps where it might have seemed most needed-in strategy and tactics. Having gone far towards mastering this department of the game, the widest possibilities are now open to this enterprising and enthusiastic player. Mrs. Longman maintained the advance she made last season; she is perhaps at her very best in handicap play, whether in singles or doubles. Miss Lintern's labours for the Association, especially in the emergency created by the death of Mrs. Apps, so cheerfully and sacrificially shouldered, left her too little time and energy to play much competitive croquet this year; released from these cares we shall expect to see her to the fore again next season. Both Mrs. Elvey and Mrs. Reeve had their notable successes, the former more especially at Hurlingham and the latter at Eastbourne. There is still no clear evidence of the emergence of a new star among women players, but the potentialities of Mrs. Daniels (whose long hoops and long shots are remarkable indeed) and Mrs. Adler were noted in these pages last year. Others coming to the fore include Lady Ursula Abbey, Miss Roe (who would do still better perhaps with less body movement in her swing), Miss Fisher and Mrs. Haigh-Smith, who won so creditable a victory in the big handicap at Hurlingham. Mrs. Tingey deserves a special word of commendation; she has come on a lot since she was here last and no doubt owes much to her husband's tuition. Robert's play seemed to improve steadily as the season went on, and reached its best at Roehampton in September.

As many as 21 players received—and 13 of these declined—invitations for the Surrey Cup. It is a pity that this very interesting competition does not seem to

draw into the lists those who should be fitting themselves to displace some of the competitors for the senior "Eight." It is impossible to do justice either to the achievements or the potentialities of all these 21; it can only be noted how even those who did actually play proved themselves to be; how good it was to see the winner, Col. Cave, back again in his best form, with the wonderful Mr. Spencer Ell so hard on his heels. Among those who could not accept, however, the name of Mr. Hollweg stands out. If ever there were a potential candidate for high honours it is he, and one hopes that the day is not far ahead when he will receive—and accept—an invitation for the President's Cup. It is sad indeed that his opportunities for competition among "top people" are so few.

The younger men whose promise was noted in our corresponding article last year have restricted opportunities for play, but most of them showed at one point or another in the season that their advance is continuing. 1959 brought some new accessions to their ranks, notably Mr. D. W. Curtis and Mr. R. F. O. Kemp, both of whom appeared at Hurlingham with handicaps calculated to strike terror into the hearts of their opponents. Mr. Curtis, who won the "Draw" in the Opens in the second week at Southwick with a victory over Mr. Kirk-Greene, one of the most difficult men in the country to beat, looks capable of anything, and with a handicap still no lower than 4 will surely do a lot of "damage" in the future. Among older players mention must be made of that spirited enthusiast Mr. Huskinson, who won the Peel Memorial for a second consecutive year; Col. Prichard, who fully earned a good reduction in his handicap; General Wilson-Haffenden, who made a rapid advance in his first season, and Mr. N. F. Blackwood, winner of the All England Handicap, who has a beautiful style and a very good knowledge of the game. Two of his fellow members at Southwick, Mr. H. A. Green and Mr. W. A. Moore, show considerable promise. Finally a word of regretful, though one hopes only temporary, farewell, may be bidden here to Dr. and Mrs. Yoxall, who have now left Cheltenham, no doubt to spread in the U.S.A. the true faith about our game. They will be much missed among us, not only for the keen enthusiasm they show, but for the fine croquet they play and the no less fine spirit in which they play it.

It was said here of the County Championship last year that the winners, Middlesex, had "a team so strong that so long as they can continue to field it, it is difficult to see how they can be deprived of the title." They were not deprived of it this year, though Surrey, with a side much reduced in strength, were worthy runners-up. Matched against "The Rest" again at Devonshire Park. Middlesex were defeated rather more easily than was the case last year. The Club Team Cup was won for the first time by Colchester, such a victory by one of the smaller clubs being particularly welcome. Teams visiting them, however, to salve their wounds tried to console themselves by the reflection that the home side was somewhat generously handicapped—a matter on which this chronicler is in no position to express an opinion. The unofficial match between Budleigh Salterton and London, now quite a well-established fixture, resulted on this occasion in a narrow victory for the redoubtable Devonians, one of the contests having unfortunately, but unavoidably, to be abandoned as a draw. The visit of an Irish team provided a delightful experience for all who met them, and we should like to see much more of these so promising players over here.

The most notable event of the year in the internal life of the Association was the move to its new offices at Hurlingham, which took place at midsummer. Previous to this a sort of interregnum had stretched over a full six months for the unhappiest of reasons, the illness and death, in April, of our well-beloved secretary, Mrs. Apps. Apart from the grievous personal loss which the Association thus sustained, a situation of extraordinary strain and difficulty arose which must have proved insurmountable had it not been for the self-sacrifice of the same two ladies who had come to the rescue of the C.A. in a similar but less prolonged crisis last year, Miss Lintern and Mrs. Thom. No gratitude to them can be too great, and a debt is owed too to Mr. Townsend who did so much to help these two with the heavy task involved in the move to the new office. Almost immediately after this transit was completed it became known that the Council had found a new secretary to initiate the new regime at our delightful new headquarters. The whole Association will give Mrs. Gasson a very warm welcome, pausing only to sympathise with Parkstone in losing her valuable services now given to Croquet in a wider context.

Much work has been going on behind the scenes on the project for producing a redraft of the Laws pioneered by its zealous originator, Mr. Ian Baillieu. The work of his committee is not far from completion, but waits upon the extended comment still to reach us from the antipodean councils, who have, however, already made known their general assent to the proposition. The Council is hoping that it may prove to be possible to issue a revised code to which all concerned are at any rate substantially agreed by the opening of next season.

Croquet players are wont to live long, but the day comes when they are no longer with us, and this year we have had to mourn the passing of some who were already famous in our little world before the great majority of today's associates had entered it. To Mrs. Apps reference has been made already; two ladies who had been even longer in the game died during the summer; the obituary notices of Mrs. Beaton and Mrs. Ernest Turner have told us something of their achievements and their services to the game, but such friendships as many of us had formed with them over long years leave memories which the printed word alone can never sufficiently preserve. And with them we shall remember one whose name has a special significance for these pages to which he contributed so much-"Crowther", the brilliant draughtsman, the witty writer, the incisive and often scintillating talker, who may sometimes have made a momentary enemy, but always re-established him as a lifelong friend.

Looking forward, we find the Triangular Test Match prospect still as it were hull down on the horizon, but likely very soon to emerge into full view. No more than this can be said now, but associates can be assured that the project is very much alive and that the Council has the matter clearly in mind. Finally, we have a very pleasant and fruitful prospect before us in the publication next spring of a book to be entitled *Tackle Croquet This Way*. Since the "way" is Patrick Cotter's way there could not possibly be a better one, and the book should do much to nourish, in beginner and "old hand" alike, that gusto, intelligence and enterprise which its author always so attractively exhibits, whether on the court or on the page.

The Chairman read letters from Mrs. Apps' daughter, the Baptist Times and the Baptist Union. The two latter revealed the extent of the esteem and affection which these bodies had for Mrs. Apps.

Canon Creed Meredith said that, in his view, it was generally the weaker player who was pegged out: it did not need very much skill on the part of a good player to wire each time and it was only a matter of infinite patience and prolonged the game. He considered his suggestion more sporting and more in the spirit of the game. Other speakers said that they considered any alteration would ruin the character of the game, as pegged out games were always the most interesting, both to players and spectators. The Chairman said there was much to be said for both sides and put the matter to the vote. The motion was lost.

#### Second Motion by Canon Creed Meredith

"That in future the selection of players for the President's and Surrey Cups should appear in Croquet in this form: 'The following players were selected. X.Y.Z. having been unable to accept A.B.C., etc., were invited and of these A.B.C. accepted'." Canon Creed Meredith said he wished to ensure that it was made clear who were the eight players first honoured by being chosen for the competitions. After much discussion it was suggested that the first eight players be published in alphabetical order, this to include the Ladies' Field Cup. The motion was put to the vote and carried.

#### Motion by Mr. Longman

"That when the Handbook is next printed the Surrey Cup be inserted from the first competition in the same way as the President's Cup and the Ladies' Field Cup. Motion by Mr. Evans

"That those members of the Association invited to play in the Surrey Cup competition shall be entitled to wear a tie, to be known as the 'Surrey Cup Tie'." This was seconded by Mr. Solomon. There was much discussion, some members suggesting that it was a great pity to take away any of the prestige attaching to the tie which was awarded to players in the President's Cup and International Events. It was later agreed, however, that the design for the tie should be submitted to the Council for approval, and that the motion should be approved with retrospective effect.

Motions by Dr. Wiggins

"That all players selected for Invitation Events sponsored by the C.A. should be charged an Entrance Fee." Dr. Wiggins said that were the C.A. in a happy financial status he would be the last person to suggest that players invited to compete in C.A. Events should pay entry fees. But could the Association afford to have expenses of this nature? The Chairman said that, in her view, if people were honoured by invitations she considered it undesirable for them to have to pay entrance fees. After discussion Lt.-Comdr. Style suggested that Dr. Wiggins should withdraw his motion for the time being until the Committee had studied the whole question of finance. This was agreed.

#### CORRESPONDENCE

A Word for the "B" Class

Dear Sir,

I think it is not realised by most people that the B class players have been treated rather badly since handicaps went up by two bisques two years ago. Now  $2\frac{1}{2}$  bisquers who would have been  $\frac{1}{2}$  bisquers two years ago are very often allowed in the B event, whereas before no one below 2 bisques (now 4), was ever allowed in that

I think this is very discouraging for the "true" B class player. It may be said that he can at least get his chance in handicaps, but this is not so as he so often meets players with larger handicaps than they should have.

I think the B class should never go below 4 (the old 2 bisques). Sometimes it is said that the higher bisquers in the A class have no chance, but at Eastbourne this year one of the B class players who should have been in the A's came within two points of winning the Women's Open Singles. Another had already won a good B class event elsewhere this year, and another got through several rounds of the A class last year at Eastbourne.

#### Ouestions and Answers

Ouestion: Has the opponent a lift if the striker shakes a ball but does not move it in aiming at a ball on the wire and only hits the wire and not the ball?

Answer: Law 30 (c). No, he has no lift as the striker has not moved the ball on the wire, see Law 10 (e). Law 30 (c) was altered in 1957 from ball "shaken" to ball "moved."

Question: Is it a foul to rest a hand or an arm, directly connected with the stroke, or rest the shaft of the mallet against any part of the leg or foot when making a stroke, even if the striker is making a forward stroke as well as during a hammer stroke ?

Answer: Yes, it is a foul. See Law 26 (o).

Question: Is this a foul ? To touch a ball at rest other than the striker's own ball with his mallet or with any part of his body or clothes when taking aim or making a stroke.

Answer: Yes, it is a foul. See Law 26 (c).

#### EASTBOURNE

#### DEVONSHIRE PARK

#### September 28th-October 10th

When the date of the General Election was announced, not only the Council but croquet players in general were faced with a number of teasing questions. If the tournament were to be held as usual, would it be adequately supported; would political zeal overcome croquetical zest in keen party workers; would those who came to play have opportunity to gather in any fruits of their labours before departing to cast their vote? In the event, all these problems sorted themselves out satisfactorily, or more precisely were sorted out by the able management which has now for so long presided over this tournament. Events were accelerated without any unreasonable strain being placed on anyone, and by the evening of October 7th, only those needed to stay on who were happy to do so, with enough left for them to engage their interest for the days which remained. But Messrs. Brackenbury and Dibley will doubtless be glad to reflect that they are unlikely to be faced with the problem again for another five years.

The weather-but what is there left to say on this subject in this miraculous summer? The gloriously warm and sunny days were the more enjoyable by contrast to the very unusual dampness of last year's tournament, and it was only on the very last day, with but a handful of games left to play, that the sun retired and some

It was doubtless expected by many competitors that in a summer so exceptionally dry the lawns would be particularly fast, but paradoxically enough the drought produced an opposite effect. So much watering had been necessary that the grass-where not worn away altogether by many months of lawn tennis—had become rather coarse, and the courts were slower and less interesting than is normally the case here. Players were not unanimous as to which court played the best, but all agreed that No. 1 (behind the stand) did not

There appeared to be five competitors with pre-eminent claims to a place in the semi-final of the South of England Championship, but since five into four won't go, one of these had to go, and the victim was the holder, Dr. Wiggins, who found Mrs. Rotherham in the almost invincible form she maintained nearly to the end of the tournament. Her first game with Mr. Hamilton-Miller in the final was distinguished by brilliant shooting on the part of the lady, but losing this by the narrowest of margins, Mrs. Rotherham seemed to have shot her bolt and could not make much of such chances as

came her way, her opponent's tactic of going right round and giving contact paying off better than it has done on some other occasions this summer. It is good to see this fine player making so convincing a come-back this season, crowning this with a signal victory on his native heath.

Mr. Kirk-Greene, who played two close games against Hamilton-Miller in the semi-final of this event, got his revenge in the Men's Championship and so retained his title here. The Women's Championship was remarkable for some striking reversals of form, most notably in Lady Ursula Abbey's victory over Mrs. Longman, and her very narrow defeat in the final by Mrs. Reevea game which must have gone the other way if excitement had not been added to inexperience in the closing stages. But Mrs. Reeve is to be congratulated not only for her calm and confident play at the end of this uphill game, but for good victories in earlier rounds. Mrs. Chittenden was not very seriously challenged in the "B" levels-though Capt. Buller made a good stand against her. Miss Forbes-Cowan, who always plays well here and seemed hardly ever off the courts, was a convincing winner of the C levels, in which event, however, Capt. Gilbey did perhaps unexpectedly well; and Mrs. Fitter was clearly the best of the bunch in the D levels and should soon find herself playing in more skilled company.

The draw for the Open (curiously described here as "unrestricted level") Doubles revealed-to the satisfaction of the rest of the competing pairs—that the two strongest combinations had drawn each other, and when Dr. Wiggins and Mr. Kirk-Greene emerged victorious from this encounter, it was generally assumed that they would win the event. But having proceeded a stage further, Dr. Wiggins found himself prevented by his medical duties from playing in the final, which thus went by default to Mr. Reckitt and Miss Warwick, who had shown themselves a combination with distinct possibilities.

Mr. Reckitt was victorious too in the Handicap Doubles, and for a second consecutive year with the same partner. But he would be—and in fact was—the first to attribute a major measure of credit for their success to Mr. Perry, whose potentialities as a player are considerable. Professing, and even at times appearing, to be the victim of nerves, his steadiness "under fire" was remarkable, and in more than one game it was a long shot from his mallet at a crucial moment which clinched the issue. A word of praise is due to Commander Beamish who played very well throughout this event, and had in addition two good victories to his credit in the Men's

The big Handicap at Devonshire Park has been for some years as it were the "personal property" of Mrs. Rotherham and it looked for some time as if she might be going to win it against at her now maximum handicap. But Miss Forbes-Cowan showed her usual fighting spirit, and despite some rather dubious tactics, emerged victorious. Meanwhile, in the other half, Mrs. Longman had been winning her games by notably large margins, and if her ultimate victory wins for her, as surely it should, a minus handicap, the recognition will certainly not have come before it was due.

Both Commander and Mrs. Style, whether in partnership or scparately, won a large number of games during the week, and the former did well in the Limited Handicap, in which Miss Doris Latham, on the eve of her visit to New Zealand, had a satisfying victory. Despite the distracting magnet of the ballot box, a fair number of players stayed on to play in Extra Events. A game in one of these drew applause for both players. Mr. Kirk-Greene, having gone round to the rover hoop with the third ball in play, Mrs. Style immediately went round in her turn taking only two bisques, and won the game using only a few more in the turn that

An experiment was made with the Pegged-Out Game event suggested in the October number of Croquet by Mr. Reckitt, with an amendment introduced by the originator requiring all balls to start from B baulk. This gave rise to a great deal of interest, and (as its proposer had hoped) discussion of the conditions tentatively laid down. Players went away saying that they meant to give the game a good try-out on their clubs, and it will be useful if they will in fact do so, since it may then be possible to agree upon the details for a form of game which clearly provides a good deal of scope not only for skill but for intelligence. Col. Stobart, showing a maximum of both on this occasion, was a worthy winner.

And so thank you, Brack, thank you Major Dibley, thank you ladies who so unselfishly brought us out our coffees and teasbut above all thank you SUN for shining so long and so radiantly on this crowning glory of a wonderful season.
