# NOTES by ROVER

#### Those in authority

In our Note on The Managerial Society in the December number we remarked on the fact that 'these indispensable manipulators', whose services are so generously given, are 'now to a dangerous extent in short supply'. It would be truly a disaster if that supply were for any reason to become still shorter, yet the Council has some ground for apprehending that this might occur. We feel certain that in a general way the efforts of these self-sacrificing officials are most gratefully acknowledged by associates. Indeed at one time tournament reports made such reiterated mention of the 'genial Manager' that protests against this cliché began to be heard; and in fact it is not a description which could always have been accurately applied even to some of the very best of them. Much as the famous 'Brookie', the first of the great Managers, was admired and even came to be loved by the majority of associates, 'genial' is hardly the word which would have sprung to the lips of many of those who took their orders from him. But even if such fully-occupied officials are not invariably genial to us, it is surely unquestionable that it is always our duty to be so to them; and it is with distress that the Council has recently received complaints that some, and these among the best of our players, have been from time to time a good deal less than courteous to those who, almost from dawn and often till dusk, have the exacting responsibility of seeing that our tournaments go not only smoothly but efficiently forward.

#### 'In the last resort. . . .'

It is not of course for a moment to be supposed that there could ever exist in our game any sort of parallel to the situation now prevailing in another Association, i.e. that concerned with the game in which players do not strike but kick the ball-yet now, it appears, too often do both to their opponents. Nor can we picture occasions when spectators at Hurlingham would not only cease to 'refrain from audible comment on the game' but would actually hurl missiles on to the courts and 'barrack' a referee who gave what might be to some an unpopular decision. Nevertheless, if those in charge of our tournaments are to be addressed by competitors in a manner and in terms which incline them to feel that they will not accept such an office in future, it will be with the full support of the Council if before making such a resolution they will proceed to disciplinary action, 'book' the offender, report his conduct to the Tournament Committee. and if they think fit exercise those powers bestowed upon them by Regulations 12b(v) and 19(h)—and in the rather different case of Referees, by the first two sentences of Regulation 4(k). As no doubt there are associates who cannot immediately call to mind what is said in these paragraphs we would urge them to refresh their memories by a study of them. If 'in the last resort' (as the last of these Regulations puts it) they find that, however eminent, these powers are put into force against them, they will only have themselves to blame. Rover's sentiments are ordinarily unofficial and not to be identified with the views of our governing body. In this case, however, readers can feel assured that our words have authority behind them.

#### Knocking-Up

This writer is strictly sheltering behind a veil of unofficialdom in commenting on one issue which continues to attract letters. A possibility suggested by the letters is that a knock-up of two minutes might be allowed in any game where none of the players has a handicap of, say, 4 or less. This would do justice to the view that to judge the speed of the lawn in a few strokes is one of the game's delicate skills-for the more proficient. But this does not apply to high-bisquers; if it did they would have fewer bisques. A brief knock-up would, they say (and for once, our legislators are perhaps not ideally placed to judge from personal experience) be invaluable in giving them greater confidence. A knock-up is ill-described as "banging balls about aimlessly" for there is a two-fold aim: to get the feel of the lawn, and to get one's eye in. In favour of the proposed restrictions on knocking-up, a low-bisquer should not need a knock-up; a high-bisquer meeting him already starts with an advantage in his bisques, and two high-bisquers meeting in any event would both have a knock-up. Nor would this waste too much time; 4 knockup periods (4 games on one court is rare anyway) would take no more than 8 minutes, and how often does play on all the courts continue until less than 8 minutes before "bad light stops play".

#### Dear Sir. . . .

There are readers of the daily and weekly Press whose main delight is to scan the correspondence columns, and indeed most of us would confess to more than a passing interest in the contents of the letters to the editor. For some time the correspondence column of this journal has been singularly barren and yet from the conversations we hear at tournaments up and down the country there is a wealth of subject matter constantly under discussion which we would have thought to have prompted associates from time to time to have taken up their pens and let the croquet world have the benefit of their views. Let it at once be admitted that these would be very welcome and if this note can stir up any action, so much the better. Are the Laws now so perfect that no improvements occur to our members? Are the arrangements for tournaments so good as to need no comment? Do we all approve of the system of handicapping? These are but a few subjects which can from time to time receive an airing in these columns. There is always an editorial risk that some enthusiastic reader may wish to ride his own hobby horse and seek to improve his views ad nauseam, but the discretion of the editor can be relied upon to keep such within

# THE 1965 SEASON

By MISS D. A. LINTERN

These notes are being written in March, but by the time they are read clubs will be holding annual meetings and making arrangements for the opening of the new season. It is hoped that the weather will be as kind as last year's, when all can look forward to an enjoyable time.

Cheltenham are again holding four short tournaments suitable for players who are unable to get leave for longer ones, and they open the 1965 season. Hunstanton follows the next week-end. In June, Woking are holding a week-end tournament; this is a wonderful effort for this club which was only started again last year with one member. Now the membership has already reached about twenty. The Council are most grateful for the efforts of these clubs.

There are two alterations to dates of long established tournaments. Nottingham, who have for some time held their week in June, have had to transfer to August, as they are unable to have their lawns for the earlier date. Southwick have altered their usual August non-official week to June 28th because it was found too much for the members who do the catering to have two weeks following. They hope very much it will not inconvenience their usual supporters.

The Longman Club Team Cup competition was a great success last year played under a regional basis and it will be the same this year. Already three new clubs have entered this competition for the first time and we are hoping others will join in, as it is such a good competition for the longer bisquers and makes for pleasant matches. If you read the new conditions for this year you will see that if two clubs drawn together cannot provide more than two lawns at either club, they may play it as two singles and two doubles, and if a tie in matches results, the winner will be the team who scores the most points.

The Challenge and Gilbey Tournament was a success in 1964, but it needs more competitors: those who played last year found both the week-end games and the rest of the week very enjoyable. The Gilbey will again be played as a week-end tournament and last year there was also an American extra event during the week-end which was on a time limit, but each player got about five games. The Manager hopes to repeat this in 1965.

The Devonshire Park Tournament will be two separate weeks as last year but the programme has been slightly altered. The B, C, and D class bisque range are as follows —B  $\frac{1}{2}$  to 3, C  $3\frac{1}{2}$  to 6, D  $6\frac{1}{2}$  to 8, all level classes, but the E class for the Felix Cup will be played on handicap 9 bisques and over. The open doubles will be played during the second week. The Manager for the first week will be Major J. H. Dibley and the second week Mr. E. A. Roper. We hope to have two more lawns at Devonshire Park this year but as yet we have not had confirmation. The Compton lawns are being very kindly lent to

us and they will be used as and when necessary. Entries will be limited. The advertisement will be in this issue of the magazine so that Associates can make their plans early. Send your entries at the same time as you book your hotel accommodation, and so avoid disappointment. The match arrangements are not complete as yet, but there is a possibility that we may be able to have it on the Sunday between the two weeks, otherwise it will be as last year—on the last Saturday.

The Council regret that owing to the greater cost of tournaments the C.A. tournament entrance fees have had to be slightly increased. These have now all been standardised. Best of three games, Draw and Process, and "X.Y." will all be 15/-. Championship Doubles will be 13/- each player, other doubles 11/6 each player. All Singles level and handicap 12/6, except the consolation events in the two championships which will be 10/-. Golf Croquet events 6/6, both singles and doubles. The All England handicap 3/6, with 2/- for the C.A. and 1/6 for the club.

Associates will have read in the Council minutes the difficulties of obtaining managers for tournaments, and this has been made even more difficult by the rudeness of some of our top players. Two managers have asked the Tournament Committee to consider suspending a player from official events if he or she is reported for such behaviour. The Committee unanimously agreed that such behaviour must be stopped. It was pointed out that on page 44, Regulation 19 (h) of the Laws, the power is already given to managers to suspend a player. The Council are anxious that this should be emphasised and managers are asked to make use of this regulation at all tournaments where the official laws and regulations are in use, and report to the Council their action. It would appear at the moment that the brunt of management falls on the shoulders of all too few: this is very hard work and means giving up a lot of time and play, and then unfortunately it is not appreciated by some of the players. The Council would like to see more of the first class players who are free to do so giving a helping hand and taking their share of work in the way of management.

News of the 1965 Conference will be in this issue and it is being held on Saturday, May 29th at the Hurlingham Club. Clubs are asked to send two delegates as in 1963, and all Associates will be welcome at the conference, but only delegates may vote.

The Council suggest to clubs that if they are short of members, advertisements in their local papers might help as this has been most successful at some clubs. Some financial help can be obtained for this on application to the Publicity Committee of the C.A.

#### Council Meetings

Chairman's Report of Council Meetings, 1964 and 1965.

#### Meeting held at 4 Southampton Row on Thursday, 19th November 1964

- Miss Lintern, Chairman, presented the Report of Tournament Committee, and Council made the following decisions:—
  - (i) That there should be no Junior Tournament in 1965. Approved *nem. con*.
  - (ii) That the Advertisement of the Longman Cup conditions shall read: "A player must be a bona fide member of a Registered Club to be able to compete." Approved nem. con. Council also approved the allocation of provisional handicaps, subject to adjustment as necessary during the course of the Tournament, to those competitors holding no official handicap.
- (iii) That the decision that the Ladies Field Cup shall not be played in London in 1965 be reversed. Approved with two abstentions. In proposing this resolution Miss Lintern had informed Council that the holding of this event in London last year had resulted in a very much better entry.
- (iv) That the attention of Managers be drawn to their powers for disqualifying players under the Regulations for Official Tournaments and that this decision shall be referred to in Rover's Notes and the Secretary's Column. Approved nem. con.

During discussion reference was made to letters received from two Managers refusing to manage any more Tournaments because of the rudeness to which they had been subjected during the past season from top ranking players. Such conduct at Tournaments was deplored and it was also agreed that to help strengthen the authority of Managers it was most desirable that top class players should manage Tournaments more often.

(v) That the following be elected as Handicappers:—

(vi) That the list of Calendar Fixtures as proposed be approved subject to the following decision as to the conditions rendering an "unofficial" tournament eligible for inclusion:— "That a Club holding an Official Tournament could hold one non-official Tournament free of all levy—but the second and all subsequent unofficial Tournaments should pay 50% of the levy." Approved by 9 votes to 2. (vii) Devonshire Park Tournament

- (a) That the Tournament be divided into two separate weeks.

  Approved 8 votes to 2 with 1 abstention.
- (b) That there should be two Managers—one for each week. Approved 8 votes to 3.
- (c) That subject to permission the Match be played on the Sunday between the two weeks, and Open Doubles be transferred to the second week. Approved nem. con.

The debate on the Tournament Committee's Report was then adjourned.

 The Report of the Apps Committee awarding the Apps Bowl to R. G. S. Shewan, and the small monetary award from the Apps Memorial Fund to the Folkestone/Hythe Club was received and approved.

#### Meeting held at 4 Southampton Row on Thursday, 7th January 1965.

- Mr. John Solomon, Chairman, presented the Report of the Laws Committee, and Council made the following decisions:—
  - (i) That a Referee of a Tournament shall be invited to appoint umpires who shall be players of scratch and under handicap —or failing such players, those of the next lowest handicap who are considered suitable. Umpires shall be empowered to judge only:
    - (a) Whether a ball has been hit.
    - (b) Whether the peg has been hit.

Approved by 14 votes to 2.

In presenting these recommendations Mr. Solomon pointed out that it was hoped that umpires would ultimately have more powers and be required to pass an examination, but it was felt desirable to start in a small way with very limited powers.

- (ii) That Mr. Roper's synopsis of the Laws after final revision be published. Approved *nem. con.*
- (iii) That a new examination book be compiled to form the basis of the examination for referees. Approved *nem. con*.
- (iv) The following amendment, in the form of a complete redraft for substitution in place of the present Regulation 8 of Regulations for Official Tournaments was approved:

Time Limits

(a) Time limits may be imposed as follows:-

- (i) The Committee of a Tournament may in any advertised programme fix a time limit of not less than 3 hours for any event, but in any series of events played in classes according to handicap or sex the time limit must be the same for all classes.
- (ii) The Manager before the start of an event may impose a time limit of not less than 3 hours for that event. He may also before the start of any particular round of any event impose a time limit of not less than 3 hours in all games in that round and all subsequent rounds. Later, he may remove this time limit or alter it (subject to a minimum of 3 hours) provided that he imposes the same time limit on all games in the same round.
- (iii) Where no time limit has been imposed under 8 (a) (i) or (ii) above the Manager may impose a time limit of one hour on any game after it has been played for not less than 2 hours, if in his opinion the length of that game would otherwise impede the progress of the tournament.
- (b) Time limited games are brought to an end as follows:-
  - When the time limit has been imposed under 8 (a) (i) or (ii) above time shall be called at the expiry of the time limit.
  - (ii) When the time limit has been imposed under 8 (a) (iii) above time shall be called at the expiry of the time limit, except that if at this stage neither side has more than 4 points to make a further half hour shall be added before time is called.
- (c) (i) When time is called the competitor in play completes his turn and the opposing side plays one subsequent turn.
  - (ii) The side which has then scored the greater number of points wins.
  - (iii) If points are equal at this stage, play continues and the side which scores the next point wins.

(d) One turn ends and the next begins as soon as the striker has completed the last stroke to which he is entitled in that turn.

- (e) (i) A bisque or a half bisque is an extra turn and notwithstanding the provisions of Law 38 may not be used after time has been called.
  - (ii) A bisque or a half bisque may however be used when play is continuing under 8 (c) (iii) above.
- 2. Council accepted with regret the resignation of Brigadier Stokes-Roberts as Chairman of the Publicity Committee and unanimously approved the following resolution. "That this Council desires to set on record their sincere appreciation of the great services rendered to the Croquet Association by Brigadier Stokes-Roberts as Chairman and member of the Publicity Committee during the last ten years."

Mr. D. C. Caporn was unanimously appointed to act as Chairman in place of Brigadier Stokes-Roberts pending the election of a new Chairman in accordance with Standing Order 26.

- On the resumption of the adjourned debate on the Tournament Committee's Report the following proposals were approved nem.
  - (i) Devonshire Park Tournament
     Handicap limits for the various classes to be as proposed.
     Classes B, C and D to be played as level events, Class E as handicap event.

(ii) Longman Cup Competition

Conditions to be altered as follows:-

- (i) If only one of the two Clubs competing can provide 3 lawns the match will be played there.
- (ii) If neither of the two Clubs can provide more than 2 lawns the match to be limited to 2 singles and 2 doubles —in the event of a tie the winner to be decided on points. The first out of the draw to have choice of venue.
- 4. A motion proposed by Lt.-Col. D. M. C. Prichard: "That it would be convenient to have a spare court available for the Surrey Cup provided no additional expense was incurred", was approved nem. con.
- A motion proposed by Mr. M. B. Reckitt: "That the programme for the Devonshire Park Tournament be published in full in the April issue of Croquet", was approved with one dissentient.
- After discussion the date for the holding of this year's Representatives Conference was fixed for 29th May at the Hurlingham Club.

#### REPORT OF COUNCIL, 1965

Since reports of all Council Meetings have appeared in the magazine it is considered unnecessary to report further at any length.

It is a matter of great satisfaction to Council and no doubt to all Associates, that all amendments to Laws and Regulations already approved are now available from the Secretary. The only outstanding amendment is that to Regulation 8 which appears in this issue and which it is hoped to ratify before the Annual General Meeting.

With the good weather the number of entries for Devonshire Park and the Longman Cup Competitions, and the increase of Associates and new Clubs, the past season may be considered highly satisfactory—only marred by certain behaviour on the courts which it is hoped will not be repeated during the coming season.

Council would like to take this opportunity of thanking the Secretary of the Croquet Association and the assistant, Mrs. Showan, all honorary Club Secretaries, Managers and Referees for all they have done for the Association during the past year.

The C.A. will be pleased to provide players, publicity and general help to all who would like to stage Exhibition games at their clubs. A Mobile Display Stand is being considered by your Committee, who hope it will be constructed and available on loan during the coming season to clubs staging Exhibitions.

Extension should be the aim of all clubs, large and small. Your Committee feel the best publicity is local publicity, which not only helps Croquet generally but particularly the local clubs without whose help the C.A. cannot expand. We urge all clubs to do everything they can to increase their membership, extend their courts, and for the larger clubs to make contact with and help the smaller ones. No existing club must be allowed to close down without every avenue being explored. If any club is in any difficulty, now is the time to contact the C.A.

Roehampton League Croquet has been an unqualified success resulting in many new members to the C.A. and new players appearing at Tournaments. Your Committee congratulate the Roehampton Club on its sterling efforts, and urge all clubs to seriously consider if they can do likewise. The C.A. will supply full details of how to start, so clubs only have to ask.

New Clubs have appeared this year, or old ones been revived. In particular the Committee wish to express their appreciation for the hard work done by Southwick for the Hove Club, Mr. Williams for the new Club at Tunbridge Wells, Mrs. Williams for her efforts at Llandudno, Mrs. Povey for getting a new club under way at Hythe, the Budleigh Club for their help to Exeter University and the Exmouth Club. Perhaps the most astonishing success of all is the revival of the Woking Club who, in one year, have expanded from one to 20 members: this shows what can be done by a few determined individuals.

Numerous others have been very active and the Committee apologises for not mentioning all the other clubs who have been active, owing to the lack of space.

Universities and Colleges provide a splendid source of new members. The Committee wish to compile a list of Universities where Croquet is believed to be played and they appeal to all Associates to let them have any information about Universities or Colleges in their district they may have. They hope local clubs will co-operate by agreeing to pair with a University or College in their area and to do everything they can to assist them.

#### Umpires Again

Once again, the word "umpire" comes into the croquet world, for the Council has decided to authorise the appointment of umpires during the coming season. Many associates will remember that some years ago an attempt was made to bring in umpires as an answer to the problems occasioned by the shortage of referees. But a further problem was thereby created, namely that it was difficult to define the duties of an umpire vis-à-vis a referee.

At that time, the distinction was that an umpire might determine questions of fact, whereas only a referee might decide on questions of law. The experiment proved unsuccessful, mainly perhaps, owing to the fact that the majority of players were unaware of the distinction between these two questions.

Nevertheless, croquet is deprived of the services of many competent players who, for their own reasons, do not wish to become expert interpreters of the law. The Council feels, however, that these associates can be given a chance of being of service to croquet by defining their powers more closely.

The most common causes of referees being called in are for the purpose of watching possible crush strokes, hammer shots, and balls in hoops which the striker is attempting to roquet. Of these, perhaps the latter is the most common.

Crush strokes and hammer shots can often be most difficult decisions even for experienced referees. But the Council feels that whilst it is not the full answer to the shortage of referees, to authorise umpires to watch (i) attempts to roquet a ball in a hoop or (ii) the peg when pegging out—and these two only—will help the situation, and at the same time be a start towards the institution of a separate and simple examination for umpires which will be concerned only with the practicalities, and not the theories, of the law.

Referees of Tournaments may therefore appoint, during the coming season, umpires from amongst players with a handicap of scratch or under, or, in the case of smaller tournaments where there may not be players of this category, from the lowest handi-capped players whom they consider suitable.

Players should respect the definitions given above in their own interest, for if they avail themselves of the services of players not appointed as umpires, they will have no redress if they are given a wrong decision.

# Notes from the Clubs

#### Cheltenham

The match against Oxford University will be played on Saturday, May 22nd. We hope to have six singles in the morning and three doubles in the afternoon. 10/- per Evening, Weekend, or other Short Tournament, or 5/- for one event only per Tournament in this category.

#### MISS D. D. STEEL

The death of Dorothy Dyne Steel on January 22nd in her 81st year has deprived our game of one of the most notable figures and formidable players that croquet has ever known. From 1922, in which year she won the Beddow Cup on her first appearance in the competition, right down to the outbreak of war in 1939, she was probably the most infallible 'machine for victory' in the history of the game. Other players in those years may have been more attractive to watch, none was more unrewarding to battle with. To be drawn against Miss Steel at this time elicited the same gasp of dismay as did a similar fate in drawing Humphrey Hicks in the late nineteenforties or does drawing John Solomon today. She relished her supremacy, and finding herself once described as 'Stainless Steel' by an admiring commentator was altogether delighted.

'D.D.', as we all called her, held her mallet at the top of the shaft with an overlapping grip which looked as if it must have involved a great strain on her wrists, and indeed it was her wrists which towards the end of her career did give way. Watching her play it was not immediately evident why she was so continuously successful. For one thing she was not a very reliable hoop-runner, often enough only 'struggling through' with no prospect of obtaining a forward rush. This she well knew herself, reluctant as she might have been to admit it, and she kept her companion ball at the side of the hoop to minimise the risk of being hoop-bound. The fact was that her split shots were so consistently accurate that she did not need any rushes to make her breaks easier. She was as impeccable a player of three-ball breaks as this writer can recall having witnessed at any period of the game.

Miss Steel was not a conspicuously enterprising performer; she would 'go all out for the big thing' when she felt that circumstances demanded it, but she preferred so to direct her games that such situations were unlikely to arise. She greatly disliked the introduction of 'lifts', which seemed to her to offer players opportunities which they had done nothing to deserve, and with the introduction of the second lift she regarded the great days of croquet as over. But she had two of the capacities which mark the master player. First, she never played better than when she was up against it; others may have been better long shots, but there were few who hit as many shots that 'had' to be hit as she did. Again, she had the perfect 'touch' which guarantees accuracy on very fast courts. If it rained the night before you had to play her you might have chances against her that you would have been unlikely to have got if it

Another characteristic of 'D.D.' was the perfect rhythm of her breaks. She moved at an absolutely even pace from the first stroke of her turns to the last; there was never any acceleration such as even some of our best players are apt to display, nor any slackening off. The effect was almost hypnotic, and it may have been a touch of jealousy which made some of her rivals liken her to a machine. Such concentration on the job producing such accuracy, however, is rather to be envied than denigrated.

Miss Steel learnt the game at the once famous Bedford Club; beginning in 1908, she won her Silver Medal the following year (these awards were for a number of reasons easier to obtain in those years than they are now). Her rise to the top was not sensationally swift, but by 1912 she had earned a place in the Ladies Field Cup and two years later she won the competition. The War once over, from 1919 onwards the catalogue of her successes is so rich and varied that it would be tedious to recite them here; the most notable are to be found in the C.A. Handbook, which it is a clear duty of and pleasure for—every associate to possess. In the twenty-one years between the Wars she won the Women's Championship fifteen times (no other lady won it more than once), and on several of the occasions on which she was not a winner she had not been a competitor. She won the Open Championship in those highly competitive years four times; she won the Beddow Cup outright in 1933 with her fourth victory, and when the President's Cup was donated to succeed it she immediately won that. She won the Open Doubles Championship five times with three different partners and the Mixed Doubles Championship six times, again with three. Her most famous Doubles partner was Col. Du Pre, and she had a wonderful record with him in the International Matches, in which she represented her country in every match in the series played here in 1925 and 1937, and in that played in the Antipodes in 1927.

A brief reference must be made to Miss Steel's skill as a captain in Handicap Doubles, for she was one of the best of these, both as 'psychologist' and executant, that this writer can recall, only William Longman, Humphrey Hicks and Miss Lintern being in the same class in this highly specialised art.

After World War II, 'D.D.', handicapped by problems of eyesight and strained wrists, became unable to maintain her form. At our tournaments she was soon to be seen more often as a Manager, serene, capable, yet in this sphere too perhaps formidable on

It is sad for those of us who remember her in her long reign as queen of the courts to think that we shall see her no more, applecheeked, with her blue eyes gleaming through her spectacles, striding with her curious springy step on the balls of her feet to yet another relentless victory. 'D.D.' had her critics, as she had perhaps her faults and her limitations. But take her for all in all, we shall not look upon her like again.

This can be a vital matter between winning or losing on the fourth or fifth stroke, but again the number of players it affects is in single figures.

#### "BEST TENS" IN NEW ZEALAND

The arrival of the December number of the "New Zealand Croquet Gazette" contains information which should be of special interest to British readers, for it tells of the two "Best Tens" which are henceforward to form a permanent feature of the N.Z.C.C's annual programme. The special interest to us in this is due partly to the fact that the trophies competed for were presented to their Council by the English Team at the conclusion of the International Tests in 1963. The use to which they should be put was, of course, left to the N.Z.C.C. to decide, but their decision to initiate contests in some ways analogous to our President's and Surrey Cups is one which the C.A. has particular reason to welcome.

The Senior Invitation event, played at Lower Hutt for the Silver Tray resulted as follows:

J. Prince 16, Mrs. Jarden 15, G. D. Rowling 13, Mrs. Hight 9, Mrs. Middlemiss 8, Mrs. Wadsworth 8, A. G. F. Ross 8, Mrs. Collins 5, Mrs. Leitch 4, Mrs. Lockett 4.

Eight of those invited were unable to accept, these including (to mention only names known here) A. D. Heenan, David Curtis and A. Brown of Dannevirke.

John Prince will of course be remembered as the young player who made so strong a challenge to John Solomon during our team's visit to New Zealand and on one occasion defeated him. To have lost only two games (to Ross and Rowling) is a fine record in such a competition as this, and he had five triple peels to his credit. That Mrs. Jarden should come such a close second will surprise none who are familiar with her consistently fine play.

The Junior Invitation event differs from our Surrey Cup in being explicitly a B class contest, for three bisquers and over. The Gold Challenge Cup for this went to K. Woollett of Wanganui who won all his 18 games. Presumably he is unlikely to be given a chance of defending it.
