Handicaps for Handicappers

At the recent conference, and at other official foregatherings at around the same time, rumblings of dissatisfaction were heard about the present system of handicaps. At the very lowest end some of the handicaps are not ideally related to each other, and further up the scale it might be desirable for handicaps to be reviewed regularly, and spontaneously altered up or down. Not surprisingly, there is more than one problem here, and before we propound solutions we should be clear on what the questions are. The first difficulty is a quite general one, an unbalance in the system, against the minus player, nearly always in favour of the good middlebisquer, and often against the really long bisquer. The middle-bisquer should always have enough bisques to beat a minus-player on any but his very best form, and should always receive enough opportunities from the longer-bisquer to be able to go round twice: and the latter is also at somewhat of a disadvantage against the A-class player who, being accustomed to picking up his breaks from the difficult positions he expects to be left by his peers, should have little trouble in profiting from the more attractive positions he may expect to be offered by opponent breakdowns. If the answer seems to be that if either player (but not both) is on form he should win, we are then faced with the paradox that to play regularly to form is in itself to merit a reduction of handicap. Or is it perhaps that these inequalities of odds are of little consequence when weighed against the enormous advantage of having a system of handicapping which can make it possible for a rabbit and a tiger to play on something approaching equal terms. For one could not imagine this in tennis or squash: for while handicapping could produce reasonable parity in terms of games or sets, the individual rallies would still remain hopelessly one-sided.

De minimis non curat lex

Even given the general framework, however, how accurate is it in detail? Can, for example, a system operating within fixed limits be expected to work? When the present levels were introduced, several players were at once placed on the lowest mark, but in the natural course of things individual handicaps will be reduced—except for those on the minimum permitted. Thus, the system is based on the (concealed) assumption that, to name but one example, our present Champion will never improve (or that we will all improve as much as he, and some more): but a moment's reflection will show that while what is assumed may in fact be the case, there is no reason why it should be, and there is certainly some evidence that it is not so—would anybody have believed in sextuples or three-ball triples, seven or eight years ago?

Can there be an absolute standard

How in fact are our handicaps to be assessed? It is claimed that this is done by reference to the idea of "the scratch player"; but do we have any such idea? What

are the marks of this chimerical person, for unlike the par in golf, we have no absolute standard to compete against; we have no stroke play, only match play. He is no tangible person, for he would improve, maybe, and our standard would have been destroyed. Moreover, suppose our upper and lower limits were 24 and 5: would we feel at all inclined to entertain the notion of "the 8-bisquer" as our standard? Yet that would be the equivalent of our scratch. There are in fact only two alternatives. We might have all handicaps measured against the handicap of the best performer: the lowest would then be fixed but the highest would be open, and further if the best improved more than the rest of us, all or most of the rest would have to go up (or his go down). The other possibility is the one we do in fact adopt-whatever our logicians may say about it-that there is no fixed point, but in assessing any one player's handicap we treat all the rest as more or less correct. We do not, however, draw from this natural conclusion that the extreme limits should not be fixed. And in fact we do find, at least at the lower end, people who would never claim to be as close in quality to our back-marker as their closeness to the back mark suggests they ought

The art of long shooting

In games in which top-class players are taking part the issue is as often as not decided by whose long shots are coming off. There are days when it seems impossible for some players to miss anything, the long shots hitting plumb in the middle with unfailing regularity. We recall Mr. Kirk-Greene in this connection at Devonshire Park some years ago when he hit in on eight consecutive occasions at distances of 25 yards and upwards. No matter how conscientiously the less proficient player practises long shots he would count himself fortunate to hit three in a row. Some years ago our present vice-Chairman, Dr. Wiggins, gave some hints on improving long shooting and they can well be repeated:—

- Contrary to general belief, tobacco does not steady the nerves and its smoke does not improve vision.
- Reading should be reduced during a competition week and only the larger headlines of the newspapers read. This rests the visual focusing apparatus.
- Never think, "I must hit this one". You won't. Result—Nervous Tension.
- Avoidance of heavy manual work for forty-eight hours before and during the competition.
- Medicinally, a pre-prandial small quantity of alcohol is helpful. Larger quantities—fatal.

To which might be added, head down, don't walk on the ball, smooth swing, and many other hints. In fact, quite a lot to remember!

Council Meetings

Chairman's Report of Council Meetings, 1965

Meeting held at 4 Southampton Row on Thursday, 4th March 1965

- Permission was granted to Mr. D. W. Miller and Mr. R. F. Thorp, who are engaged in writing a book on Croquet to quote extracts from the Laws of Association Croquet and other works of which the copyright is held by the C.A.
- Lt.-Cmdr. G. W. Style, Chairman, presented the report of the Finance and General Purposes Committee. The report was adopted and the following decisions made by Council:—
 - (i) That the adoption of the Accounts and Balance sheet as presented in the Report be approved.
- (ii) That in future the advertisement rates for Croquet should be as follows:—
 - (a) Advertisements of Club Tournaments—£4 per column, £2 per half column, subject to 25% discount if a Report of the Tournament was subsequently published in Croquet.
- (b) Messrs. Jaques' advertisement £10 10s. 0d.
- (iii) That since it had been found essential to have more help in the office and as Mrs. Showan had kindly agreed to take on more hours per week her remuneration to be increased by £52 p.a. Mrs. Gasson's altruistic request that she be allowed personally to defray this cost was politely but firmly declined.
- (iv) That the entry fees for C.A. Events in 1965 should be as follows:
 - i All events played on the Best of Three or Two Life System 15s. each.
 - ii All other single events except DuPre Cup and Plate 12s. 6d. each.
 - iii DuPre Cup and Plate 10s. each.
 - iv All championship Doubles 13s. each.
 - v All other Doubles 11s. 6d. each.
 - vi Evening Tournaments 5s. each.
 - vii All England Handicap (1s. 6d. to Clubs, 2s. to C.A.) 3s. 6d. each.
- viii Golf Croquet Events 6s. 6d. each.
- (v) That consideration be given to the production of a very short and simple "Introduction to the Game of Croquet" by Mr. J. W. Solomon.
- 3. Council unanimously approved that the last sentence of Standing Order No. 26 be amended to allow an Hon. Treasurer who was also serving as Chairman of the Finance and General Purposes Committee to continue so to serve more than 4 years in succession if it was considered desirable in the interests of the Association.
- Mr. Derek Caporn, Chairman, presented the Report of the Publicity Committee. The Report was adopted and the following decisions made by Council.
 - (i) To concentrate all publicity efforts this year on local clubs rather than in the form of national advertising.
- (ii) That all possible help should be given to the Hythe Club and the new Industrial Club at Epsom.
- (iii) That £10 from the Publicity Funds be given to the Cheltenham Club to help them with their ambitious advertising campaign for 1965.
- (iv) That a list should be drawn up of Universities, Colleges, Banks and Industrial Firms, and local Clubs asked if possible to get in touch with any in their vicinity.
- (v) That the questions of National Croquet Week, a panel of Instructors, fees to be charged for instruction and a panel of Speakers be raised at the Conference to be held on the 29th May.
- (vi) That £50 be allocated to the Publicity Committee for expenditure during 1965.
- It was unanimously agreed to make a grant of £25 from the Bishop Legacy to the Tunbridge Wells Club.

Meeting held at the Hurlingham Club on Monday, 24th May 1965

- Council approved a request from Miss Lintern, Chairman of the Tournament Committee, that to try and avoid unfortunate clashes, Clubs be asked to decide as early as possible on proposed dates for weekend Tournaments and to submit such dates to the Tournament Committee by the first week in October if possible so that the Committee could make suggestions as to the most suitable dates. It was further agreed that this matter be raised at the coming Conference.
- Mr. J. M. Rivington was re-elected as Chairman for the ensuing year and Dr. W. R. D. Wiggins was re-elected as Vice-Chairman.
- 3. In accordance with Rule VI 1 (b) (ii) it was decided that Cmdr G. Borrett, Mrs. D. C. Caporn, Mr. E. P. C. Cotter, Mr. H. Denny, Miss D. A. Lintern, Mr. E. A. Roper, Dr. W. R. D. Wiggins and Mrs. R. R. Williams should fill the 8 full-term vacancies on Council and Mr. D. W. Miller the part-time vacancy.
- 4. After considerable discussion a proposal by the Chairman to vary Standing Order 1 and curtail the 8 meetings between October and April inclusive, to 3 meetings, to be held on Saturdays and to commence at 11.45 a.m. instead of 2 p.m., was adjourned to a later meeting.
- In accordance with Standing Order 26 the Standing Committees were appointed—as detailed in the July Croquet.

At the conclusion of Council's meeting the members of various Committees formally met and elected their Chairmen.

- Council were informed that permission had been given by Devonshire Park authorities for the Annual Match to be held on Sunday, 3rd October and decided that this year the teams should be selected not on an international but on an underthirty versus over-thirty basis.
- 7. It was unanimously agreed to make a grant of £25 from the Bishop Legacy to the Woking Club.

Club Competitions

ROEHAMPTON

The Relay Variation

Teams are made up as evenly as possible. Team Blue and Black playing Team Red and Yellow.

After twenty minutes play, a whistle is blown and the game stops immediately. All Blue and Black players move forward a lawn, say from lawn 1 to lawn 2. When everyone is settled, the whistle is blown again and you continue for another twenty minutes either starting the next turn or continuing the break that was left in progress.

At the end of this twenty minutes, the whistle is blown again. All Red and Yellow players move down a lawn, say from lawn 4 to lawn 3, and this changing about continues, until one game in finished, or all games completed whichever has been arranged beforehand.

Some sort of handicapping may be necessary to ensure that the higher bisquers get as much play as the others in the competition. This can be arranged by trial and error.

I make the following suggestions:

All minus and scratch players become 0.

1/2 to 3 become 1/2 31/2 to 5 become 1/2 51/2 to 8 become 11/2 9 to 12 become 2 13 to 16 become 3

Thus if a $\frac{1}{2}$ plays a $1\frac{1}{2}$ he gets 1 bisque in the twenty minutes. If a 0 plays a 3 he gets 3 bisques in the twenty minutes and so on.

The American Variation

This is played in blocks, according to handicap, usually 4 in a block 1 and 3 back, time limit $1\frac{1}{2}$ hours.

An exceedingly pleasant day's Croquet.

Doubles played on the full bisque system, a high bisquer playing with a low.

A New Club Competiton

The Rev. W. J. Graham Hobson presented to Parkstone Club a Cup. Competition to be annual. He expressed three wishes: games not to last more than 2 hours; players to be encouraged to speed their play; excessive defensive tactics to be discouraged.

To achieve this it has been decided from experience that in the first qualifying round the two lowest handicaps should play each other, the next two play each other, etc., i.e. each person is playing someone near his standard. The competition to be concluded in 2 or 3 days. Each game to last not more than 2 hours. No stroke made after the call of time can make a point. A point scored by a stroke made before time is called, though the point is made after time is called, will count.

Those who have scored the most points whether winners or losers pass to the next round.

If sixteen players enter, the eight top scorers pass on and carry their points with them. You may win your game but fail to qualify. You may lose your game and yet qualify. Thus all are encouraged to make points rather than to thwart the opponent.

The first qualifying round must have an even number of entries. After the first round, if one of the top scorers scratches the next highest comes in.

If the entries are not eight, sixteen or thirty-two the Committee decide how many play in the second qualifying round but at some stage it is necessary to bring it to eight qualifiers.

For example, 20 enter, you may let the best 14 total scores proceed, and from them the best eight totals go forward.

With a 2-hour limit we based handicaps on games of 14 points i.e. about 2/3 of the full handicap. Clearly all games of each round must be completed before the entrants for the next round can be known. After the first qualifying round and in all succeeding rounds the two top scorers play each other, then the next two and so on. At all stages you carry your aggregate of points with you. I give some details of our experience.

Sixteen entered; in four of the eight games the winner scored the full 26, the other four best scores were 20, 13, 12 & 9, one 26 then retired and a player with 5 points came in. The three remaining 26 had to draw. Two to play each other, the third to play the 20; 13 played the 12 and 9 played the 5. After this round the result was: Major Hill-Bernhard 47, Canon Creed-Meredith 45 and Mrs. McMordie 43, Mrs. Devitt 38. Meredith scored 19, Hill-Bernhard 15, Mrs. McMordie 19 and Mrs. Devitt 16. Mrs. McMordie 62 and Major Hill-Bernhard 62 had to play a two-hour game (in this, the winner's points were not added to his aggregate) to decide who should play Canon Meredith 64, in the final. Mrs. McMordie won and entered the final 2 points in arrears, but owing to her illness the final had to be postponed. At all stages players went for hoops, forward play was in evidence and great interest was manifested. If any point is not clear Canon Creed-Meredith would clarify it.

Notes from the Clubs

Compton

The spectators at the Saffrons during breaks in the cricket for tea or rain often wander across to Compton to watch croquet. Those who appear most interested always seem to be on holiday from some remote part of Scotland. It was a pleasant change last week when Gloucestershire's opening batsmen, R. Nicholls and C. A. Milton came over with the intention of playing croquet. Nicholls had never played before and Milton only once—in Melbourne. They certainly enjoyed it. Perhaps the Bristol Croquet Club will be able to follow the matter up.

Being warned by the article in June *Croquet*, Compton has decided to run its Handicap Doubles on rather different lines. The competition is limited to 8 pairs, who will be divided into 2 groups of 4. The members of each group will play each other in the afternoons of July 15th, 16th and 17th. This needs only 4 lawns for the three afternoons. The group winners will play the final on July 18th. The entry list was quickly filled, but at the time of writing the event has not yet taken place.

Cheltenham

If you are looking for a little variety in the game, while yet keeping all the pleasures of the real thing, try this.

The balls are set in a standard position—Red two yards south of 2, Yellow two yards west of Peg, Blue in first corner, with Black two yards north-east of it; Blue's clip on hoop 1.

Black's clip is placed according to the player's handicap—D class on the Peg, C class on Rover, B class on Penultimate and A class

Each player in turn takes Blue round and pegs out Black and Blue using bisques as necessary. The winner is the player who has used the smallest number of bisques to go out.

We played it on the last afternoon of a week-end tournament, and to help the funds charged a shilling for two tries. It was won by an A player, second was a C player, and third a B. Scores ranged from 4 to 16 bisques. So the handicapping seemed fair—but if the high bisquers win too often, try starting from fourth corner instead of first.

Roehampton

On 12th June we played Southwick away and won all 6 games. The return match at home on 22nd June resulted in another win by 5 games to one. On 17th June we played Dulwich at Golf Croquet which we won by 5 games to 4. In the League matches we have played Mullards, Beechams, Parsons Green and Woking We drew with the first three one match each and lost to the last, 2 games to nil. We have still to play Worton Hall. In these matches we only play long bisquers which gives them an opportunity to play in competitive club matches. We are all busy with our club tournaments and look forward to welcoming old and new friends to our tournament in September.

Glasgow

On Saturday, 26th June, the Glasgow Croquet Club played against the Edinburgh Croquet Club on the lawns at Lauriston Castle, this being their first inter-club match. In spite of a week of torrential rain and high wind the afternoon (except for a very brief interval) was one of bright sunshine, so that both players and spectators enjoyed the occasion. The Edinburgh team won by 2 games to 1.

The return match is scheduled to take place at Pollok Estate on Saturday, 14th August, when the Glasgow team hope to reverse the result.

Dr. J. O'D. Alexander continues to enthuse the members of the club and is specially encouraged by the keenness and skill of some of the junior players.

Questions and Answers

Question: A, after taking croquet with blue off red, leaves his stance and walks toward blue; in doing so, he treads on and moves red, which had come to rest before blue has come to rest. Has he made a fault?

Answer: No, the provisions of Law 32 (a) xi do not apply, for although the *stroke* had not ended, the striking has. (Laws 34 (a) and 31 (c)).

Question: A tries to run the first hoop with blue and thinks he has succeeded but tests by a referee show that he has not run the hoop. When he comes on the court again he sees that blue now appears to have run the hoop, and tests by another referee find that blue is now in fact "through" the hoop. If you were the second referee, what would you decide?

Answer: Blue has not run the hoop and must be replaced where it lay at the end of A's first turn. (Law 22)

CAMBRIDGE UNIVERSITY TOUR, 1965

Last year before the Varsity match the Cambridge University team made a tour of some of the clubs in Southern England, including Cheltenham, Budleigh, Parkstone and Compton. This year a similar tour was made, with matches being played against Roehampton, Colchester, Compton and Southwick. In terms of results our tour this year did not match last year's success. This was partly because we were handicapped by the loss of our three best players, Rupert Thorp, James Laurenson and David Miller. This year we had the good fortune to have Keith Wylie playing for us. Having beaten Arthur Reed earlier in the season, Wylie played his singles with increasing confidence through the tour. His narrow victory over Dr. Wiggins was certainly the greatest achievement of the tour. With a good command of tactics and a pleasing style, he seems likely to become quite a formidable player in the not too distant future.

In every match defeat was caused by the loss of most of the oubles. Not a single double was won until Hallett partnered Wylie as the top pair, after which at least one double was won in each match. Our captain, Andrew Mozley, never quite found in last year's form, and Alexander and Martin, our numbers five and six, though improving steadily and increasing in confidence, never actually won a game. At Colchester, however, Martin was well ahead of C. S. Ratcliffe by the time the game had to be abandoned. Ian Banks, who had been off form earlier in the season, played very well on tour and won all his singles.

We found this year, as last, that the tour was good training for the Varsity match, and gave experience and encouragement to all of us. We are very grateful for the hospitality and kindness shown us everywhere we went, and feel that the tour this year has been a general success.

This year saw the fifth Annual Varsity croquet match, and we hope that the event has now become established in the calendar. Leaving aside the matter of the recruitment of young ladies to play croquet, though a tradition of croquet of good standard has now been established at Cambridge, its continuance is a matter of chance, and can only be maintained if sufficient undergraduates are willing to devote the time and energy to get themselves up to standard.

VARSITY MATCH

at HURLINGHAM-22nd June

The weather this year was the worst we have had for a Varsity match, but this did not prevent Cambridge from making a clean sweep of the games that were finished and thus maintaining their unbeaten record.

The standard of play was disappointing, particularly in the doubles, which lasted so long that the singles games which had been pegged down in the morning were never completed. This is most unsatisfactory, and it seems that as long as relatively inex-perienced players make up the lower half of each team, it will be necessary to impose strict time limits—odious as they are—on games: a result on time is surely preferable to the five-hour doubles game we had to put up with this year.

It is worth pointing out that the blame for the inordinate length of the third (unfinished) doubles does not entirely belong to the players concerned. For it is obviously unwise, and even irresponsible, not to put at least one experienced player in each doubles pair, whenever it is possible. That Cambridge deliberately decided not to do this is little to their credit; particularly as hy acting this to do this, is little to their credit: particularly as by acting this way they virtually compelled Oxford to follow suit.

Only the top doubles produced anything resembling croquet

after lunch, when Shewan, the Oxford captain, played a perfect break to 4-back, before Cambridge had recovered from winning the toss. But his partner was unable to emulate this, and Cambridge, once they had seized the innings, lost it only once, and then not fatally.

The singles were more entertaining. Wylie had most of the play in his game with Shewan, but it was a closer match than the top singles usually is. Both Hallett and Banks won by virtue of their greater concentration: their opponents tended to shoot beautifully and then leave the balls parked in the middle of the lawn. Whitmore had nearly beaten Alexander by lunchtime, but the other two games could have gone either way.

Hardly a vintage for either side, but the overall result belies the closeness of the games. May next year produce similarly well-matched teams, but more expeditious croquet.

His tussle with Reggie Leonard might have gone either way, and this match lasted nine hours. His semi-final against Frank Stobart was played in a full blooded Force 8 gale, but with his Naval experience he weathered the storm rather better than his landlubber opponent, and won the second game with a classic double peel which was a delight to watch.

The final with Douglas Strachan gave us a tremendous battle in the first game, but having won that from behind, Strachan went from strength to strength and won the second easily.

The Handicap Doubles was won by the holders, Geraldine Fitz-gerald and Frank Stobart, after some hair-raising incidents—hoop

running not being the strong point of the winners.

The writer of this was fortunate enough to be playing most of the week and was thus not able to watch the handicap events or pick out other players who deserve a "mention in dispatches"
