#### **CONDITIONS OF PLAY-1967**

THE FOLLOWING conditions of play will apply to all Tournaments throughout the 1967 Season, and will not be published in any subsequent edition of "Croquet".

#### GENERAL CONDITIONS AND INFORMATION

THE FOLLOWING conditions apply to all tournaments advertised below unless specified to the contrary in any advertisement:-

- 1. The tournament will be played under the Laws of Association Croquet and the Regulations for Official Tournaments.
- 2. The Tournament Committee reserves the right to refuse an entry without giving a reason. In particular, entries will not be accepted in excess of the capacity of the lawns.
- 3. If there are very few entries for an event, the Manager may play it on the American system, even though otherwise advertised.
- Hoops will be 3.3/4" wide. Jaques "Eclipse" balls will be used.
- 5. Flat-soled footwear must be worn on the lawns.
- 6. In C. A. tournaments no leave will be granted before the draw has been made. Application for leave on the first day will be considered immediately after the draw by the Manager or a deputy authorised by him. Leave on other days may be given by the Manager only. In other tournaments leave may be granted by the Manager or his authorized deputy, if the needs of the tournament permit.

- 7. Entries for C. A. tournaments must be made on Official Forms and must be accompanied by the entrance fee (which includes levy) and any Tribute due. Tribute is payable at the rate of 25s. per tournament or 12s 6d. for one event only, for all Calendar Fixtures, Official or Non-Official, by all except those competitors paying the standard rate of subscription (i.e. 50s.) and Junior members or others playing in their first Tournament. It is helpful if entries for other Tournaments are made on the Official Forms. In any case entrants should give the address and telephone numbers if possible, which will find them during the tournament: entrance fees and any Tribute due must be paid before the draw.
- 8. Winners of Trophies will hold them for one year or until next competed for, whichever period is shorter.
- (i) Play will normally commence at 10 a.m. each day, but the Manager may arrange an earlier start if he feels it desirable.
  - (ii) All competitors must report to the Manager on arrival. Any Competitor who is not present or is otherwise unable to play when called upon to do so will be liable to be scratched.
- 10. Competitors will be made Honorary members of the Club for the duration of the Tournament.

THESE CONDITIONS APPLY TO ALL TOURNAMENTS EXCEPT WHEN OTHERWISE STATED.

## NOTES by ROVER

#### Crinoline to Mini-skirt

HOW WOULD OUR WOMEN players compare with the early champions? Could one of them, as a novice, who had never before played in public, beat a man who was recognised as the best player existing?

This was achieved by Miss Gower, in 1898 at Budleigh Salterton, and later in the year, in tropical heat, at Wimbledon, she again defeated Mr. Willis, the Champion of the United All-England Croquet Association. The Ladies' Field commented 'This proved that a woman could compete with success in the conflict of nerve, endurance and hard work which a week of match croquet involves.'

Gone were the days when the fold of a dress inadvertently dislodged a ball lying against a wire and placed it in position for the hoop. Gone too, the dainty placing of a tiny foot, encased in kid, on her own ball, while her croquet stroke sent the other ball into the shrubbery.

One hundred years ago, on many lawns, men were prohibited from using two hands to hold their mallets. Their elegant opponents screened their complexions from the sun by parasols, leaving them only one hand to play with, and so were naturally reluctant to allow the opposite sex any advantage.

Miss Gower proved that hard hitting men could now be tackled by a young woman who had advanced beyond the tight croquet, and cages, and hour-glass mallets of the crinoline school. In the age of the mini-skirt, with two notable exceptions, few of our women players are in a position to compete with the talented male player on equal terms. It is to be hoped that an event and conditions to suit their prowess will shortly be instituted, which for those unable to qualify for the 3 Eights, will take the place of the suspended Ladies' Field Cup.

#### In Consequence Another Rover Writes

THE 3 EIGHTS which were first played last year look like establishing themselves as regular encounters to be fought out by the 24 most formidable players who are available. In the forseeable future there are two facts which emerge with a degree of clarity. Firstly the two leading Lady players, Mrs. Rotherham and Miss Warwick will be sure of a place and secondly there are no other ladies likely to gain a place. Last year 7 players were invited and refused and all were men. For the second year in succession the Ladies' Field Cup has been suspended. The wisdom of this decision is not questioned but surely the moment is now ripe to establish a new and less exalted event at which the ladies can aim their sights.

It is suggested that it be played in Eights week and be known as the Ladies' Invitation Event for competition between the 8 most formidable lady players, who have not attained selection for any of the 3 Eights in the current year. The conditions of play should differ from that of the other Eights because history has proved that 3 games a day played over  $4\frac{1}{2}$  days is too great an endurance test for players of the gentler sex who have not the form to make the senior grade.

It is suggested, therefore, that the selected eight ladies play each other only once with 2 games a day Monday - Wednesday inclusive, and one game on Thursday which would leave the afternoon for pegged-down games, if any.

It is inconceivable that a venue could not be found and there is a substantial RAGE of ROVERESSES who support this plea to the Council and who would indemnify the Council against the cost of paying for a chosen venue.

The ladies play an essential part in the Croquet World so felicitously described by Miss Kathleen Waldron in a passage

which appeared in the January Gazette. Therefore it is only fair and right that the Council should take action to ensure that there are more ladies gracing the lawns during the interregnum of regular tournament play occasioned by Eights week. A new horizon of endeavour would be opened to far more than the eight players fortunate enough to gain a selected place.

#### Rover Comments on the New Mandate

THIS YEAR the Council decided to review the principle on which the contestants for the three Eights should be selected for the current year. The result in a new mandate to the selectors, which appears on page of this issue. In many ways, it is revolutionary. It could be that this mandate will be repeated year by year, but the Council for the current year can never absolve itself from the responsibility of deciding what is appropriate. For instance the Council have decided that the holder of the President's Cup should be entitled as of right to defend his title. There was considerable discussion on this topic during the playing season of 1966. The balance of opinion, as collected by this Rover, was in favour of the proposition, but it was not in the old mandate. Now it appears in black and white. A similar right of defence if a title is also given to the winners of the other Eights, providing that they have not earned promotion to a higher Eight. Likewise a place in the President's Cup is reserved for the winner of the 1967 Open Championship. It is almost inconceivable that he would not be chosen under the old mandate but the Council have taken the view that he is entitled to the honour of being an automatic selection. The next innovation is that the remaining contestants are being chosen in ranking order.

The Council for the playing season 1968 will have to decide whether this practice is to continue. One reason for this innovation is that the contestants for the other two Eights must of necessity be chosen in ranking order so that they can move up the ladder as vacancies occur. Thus, all are treated alike. By far the most important innovation is that the Selectors are no longer instructed by the Council to base their selections on the best current form during the preceeding twelve months of play. This was all very well when the likely contestants were a leisured class playing the croquet circuit. The commitments of modern life make it impossible for many of our masters to play regularly in Tournaments.

The present instructions give the selectors a wider discretion. They are to be the judges of what they consider to be the relevant material in selecting the most formidable contestants available. The same principle is to be followed in selecting the 2nd and 3rd Eights. The Surrey Cup is now officially the 3rd Eight. It was treated as such in 1966 but one could find no words to justify this in the advertised conditions. A further principle has been established. No one can refuse promotion and all invitations to the minor Eights are now issued on the condition that a person selected must accept promotion or withdraw. The effect of this should be closely studied. If it works inequitably it can be revised. On the other hand any contestant can decline to accept demotion. How does that provision work? A player may inform the Secretary of the C. A. or the Selectors, "I will hold myself available to play in the President's Cup. If I am selected 9, 10 or 11 etc. on the roll of honour and the necessary vacancies occur I would like to be considered, but I will not in any event be available to play in the Chairman's Cup." Difficulties may arise in the case of last minute stand-in reserves. Experience may prove that the mandate may need some revision. So be it, the document is at the moment only an annual document to be annually revised. There is one last innovation which, it is hoped, will give universal satisfaction to players. There will be no secrecy after selection. The many players who are always assembled at Hurlingham will no longer be composed of two uneasy groups, those who know and those who do not know.

- 10/- per Evening, Weekend, or other Short Tournament, or 5/- for one event only per Tournament in this category.

- 1. Evening Tournaments are those which start at 4 p.m. or later and which do not last longer than one week.
- Weekend and other Short Tournaments are those which do not exceed four days' duration.
- Regarding category (b) above, the words "one event only" apply both to the player and to the Tournament itself, that is to say a non-Associate entering one event only in a multievent Tournament is liable for Tribute at 5/-; and if a Tournament consists of one event only the liability of each non-Associate entrant is 5/-.
- Players are reminded of the once-for-all benefit by which no Tribute is payable by a non-Associate entering a Calender Fixture for the first time.
- 5. Levy is payable by all competitors in Official Tournaments and forms part of the entry fee charged. The rate is 3/6 per event. Provided an Official Tournament is held, every club is entitled to include in the List of Calendar Fixtures one Unofficial Tournament free of any levy. In the respect of a second and all subsequent unofficial Tournaments, half levy is payable, i.e. 1/9.

The All England was first played in 1923 when 529 players entered from 48 Clubs, and in the following year 541 players entered from 41 Clubs. Already we have beaten the number of Clubs with 50, and we hope we shall easily exceed 541 players. It would be splendid if we could get at least 60 Clubs to compete and 1,000 to play, and we can if everyone will enter. If we all make a special effort this year then I believe we shall be amazed at the results.

In the ultimate, the success of the year does not depend on the Council but on the support of individual members of the Association - I hope you will all give this.

That the Ladies Field Cup shall NOT be played in 1967.

#### MANDATE

Mr. Rivington proposed that the Chairman appoint an ad hoc subcommittee to consider what mandate the Council should give to the Selectors directing them how to choose the first three "Eights".

That grants of £25 each from the Bishop Legacy be made to Eastbourne College of Education and to Miss Samuel of Uppingham, thereby extinguishing the Bishop Legacy Fund.

Commander Style concluded by advising Council that owing to pressure of other commitments he greatly regretted that he could not let his name go forward for re-election to the Council when he retired by rotation at the next A. Mandate for Selection Committee Approved. (And Follows).

Prior to the Meeting of the 7th January, Co. Dublin had been invited and had accepted the invitation to play in the Inter Counties Championship. On that date it was not known whether any extra lawns would be available to enable the competition to be played as in previous years. The Secretary was able to inform the Council that Roehampton Club had agreed to provide the extra lawns necessary so that the condition of play will remain as hitherto.

Owing to lack of time the report for the Laws Committee was not received.

#### MANDATE

Report of the ad-hoc Committee set up to consider what Mandate the Council should give to the Selection Committee.

Members of the Committee: Dr. Wiggins, Mr. Baillieu, Mr. Reckitt, Major Dibley, Mr. Cotter, Mr. Solomon and Miss Lintern.

#### RECOMMENDATION

- 1. The final selection shall normally be made on the 2nd Tuesday of the Hurlingham tournament.
- The holder of the President's Cup, and the current winner of the Open Championship shall be automatic selections for the President's Cup. The Selection Committee shall then select in ranking order the six/seven players whom they consider are the best qualified to compete in the President's Cup.
- The Selection Committee shall then continue to select numbers for a further 22 players, or as many more as they think necessary, all in ranking order, to act as reserves for the President's Cup, or as competitors or reserves for the Chairman's Cup (the 2nd eight) and the Surrey Cup (the 3rd eight). All the above selections will be made on the basis set out in paragraph (2) above.
- The fact that it is known that any player will not be able to accept an invitation shall not preclude him from receiving an invitation.
- All invitations shall be issued subject to the condition that the person selected shall accept promotion to a higher event should a vacancy occur up to the 4th full day before the beginning of the tournament. If any such person does not accept the promotion, he will no longer be eligible to play in the event for which he was originally invited.
- The Committee may select for each of the 3 events a "sitting" reserve who shall be available during the 4 days prior to the tournaments, and up to the actual beginning of the tournaments. They shall be chosen principally with regard to convenience of location, but as being, so far as possible, also of such a standard as not to impair the quality of the tournament. A player who has refused an invitation for a lower eight shall be eligible to act as a sitting reserve.
- "The following players have not been ranked because of the absence of evidence of current form".

Underneath this heading, the Committee may in their discretion add further names; but no person shall appear in this list unless he was invited or played in the preceeding vear.

- Having completed their selections, the Committee shall forthwith issue invitations on behalf of the Council to the players concerned, and a list shall be posted on the tournament board at Hurlingham.
- 9. Mr. J. M. Rivington's amendment. That the holders of the Chairman's or Surrey Cups, unless invited to play in a higher-event, shall have the right to defend their Cups whatever their ranking.

It will be of considerable assistance to the Committee if any person who has reason to believe that he will be considered for selection. and knows that he will not be able to accept any invitation, so informs the Secretary of the C. A. This shall not prejudice his right to be ranked, or to accept the invitation that he will in any case receive under paragraph (4). So far as possible this information will be made public knowledge during the season for the convenience of other aspirants.

#### **OBITUARY**

W. LONGMAN

WITH THE PASSING of William Longman the Association mourns one of its most eminent figures; both as a player of long standing and as an administrator of great experience and sagacity. He first came into prominence in first class croquet when, while only a  $2\frac{1}{2}$  bisquer, in 1911, he beat first Cyril and then Herbert Corbally in the Open Championship when these two players were at the height of their powers, indeed the elder (Cyril) was only defeated in this event on one other occasion. It was not until 1914, however, that he won a place in the 'Best Ten' (Beddow Cup). He was chosen for this again in 1920 and henceforward achieved the extraordinary record of selection for this every year from to and including 1936, and then again in 1938, he having been victorious in 1925 and runner-up in 1922 and 1926. He appeared in the President's Cup in 1953 and again in 1957 - thus according a span of 43 years between his first and last appearance and a so far unbeaten total score of 21 of these in all.

Through the greater part of this time Mr. Longman's opportunities of playing in first class events were limited by his responsibilities as a member of the famous publishing firm the name of which he bears, but from the early twenties he was always to be found at the Southwick tournaments and won the Opens there on a number of occasions. One of his particular skills was the pioneering of high bisquers through handicap doubles, and the most auspicious of all these successes was achieved in 1930 when having been given a partner Miss K. E. Stuart, a young lady who had only started playing two months before, he won the event with her. Their engagement and marriage followed only a few months later. Only three years after this his tuition resulted in the selection of Mrs. Longman for the Ladies Field Cup for the first of many times.

During the inter-War years 'Willy' was one of the most consistent triple peelers of that period. He was a master of the tactical side of the game and a notably good long shot. Indeed he remained a formidable opponent for a dozen years after the War and won the Men's Championship at Devonshire Park then on several occasions, and continued to play for Sussex in a number of these seasons.

When Mr. Longman was elected Chairman of Council in 1924 he was the youngest associate to be selected for this responsible position up to that time, and since then only John Solomon has been younger. Some very tricky problems arose during the two years of his Chairmanship and the wisdom and tact with which he handled these was much admired by his colleagues. He was elected Vice-President soon after the War.

His marriage produced one of the most notable alliances our game has known. Deep sympathy for Mrs. Longman and admiration of her care for Willy in his latter years will be felt now by all who knew them.

#### THE EDITOR CONTINUES TO WRITE

THE NAME LONGMAN has been associated with croquet since the introduction of the game to England. His family publishing firm privately printed for the current Mr. Jaques the first set of Laws in 1857. There were several fresh editions published and by 1865 65,000 copies had been sold. The two books written by Mr. Lillie at the turn of the century, both now croquet classics, were also published by his family firm. His uncle Sir H. H.

Longman Bt was Chairman of the Croquet Council from 1914-1920 and in 1930 was appointed a Vice-President. In October 1921, "Willie" contributed an illustrated article for the current "Gazette" headed "Croquet in the 1860's". He probably had the finest croquet library in England until the books were lost in the Blitz. His article which covered 7 pages might well lay claim to being the most important historical article ever to appear. In this Centenary Year I had hoped to write a fresh artical based on the original. I hope now the Council may somehow or other be able to reproduce the original in full. There is one further fact. I have it on the authority of Mr. Robert Tingey that he was the greatest contemporary teacher of the game.

#### THE WRONG BALL LAW

SINCE THE CLUB DELEGATES on a motion proposed by Roehampton, which was said to be a unanimous decision, invited the Council to reconsider the present rule which they regarded as oppressive, I have made researches into the past; because in my capacity as Editor rather than in my capacity as Chairman of the Laws Committee, I think the subject is one on which the Council should largely be guided by the conscience of the modern croquet player. I have read enough to be satisfied that the wrong-ball rule has provoked more controversy, aroused more tempers and undergone more changes than any other rule in the history of the game. Witness the acerbity underlying an anecdote upon which I chanced and which is printed below.

At the turn of the century the present harsh rule prevailed. In addition the striker was equally penalized if he took croquet from the wrong ball (Law 29A), took croquet when he was not entitled to do so (Law 29B) or failed to take croquet when entitled to do so (Law 29C). I looked up the Laws again in 1906-1908. The rule was completely transformed. If, then, the error was discovered before the second stroke in error, there was an automatic replay without penalty. If the error was discovered after the second stroke in error but within the limit of claims, the irregular play was cancelled, all balls were returned baulk and the right player with the right ball began the play. I next looked up the Laws in 1935. These Laws were amended in detail between 1935-1938 inclusive. However the basic idea was that if the error was discovered before the second stroke in error there was a replay without penalty; if after the second stroke in error there was a replay or substitution as under (Law 29A). In 1939 the Law was completely redrafted and its operation simplified. The rule then was that the balls were first replaced without penalty and the striker continued his turn as in a half bisque turn, that is to say, no further point could be scored for any ball. The present rule dates back to 1948. An abortive attempt to dislodge it was made during the redraft. The suggestion then was that after the balls were replaced the striker should be allowed one more stroke which might enable him to disperse the balls and so avoid a four ball break changing hands.

#### **OUESTIONS AND ANSWERS**

The Question in this issue is what should be the appropriate rule for playing the wrong ball. Clubs are invited to express their opinions along the following lines.

"The Committee/Members of - Club by a majority of - to - are in favour of abolishing/retaining the present rule.

This Club is in favour of:- (Reverting to the 1939 Law or whatever the suggestion, if any might be)."

#### BY OUIS AN UNUSUAL ANECDOTE

T WAS THE FIRST DAY of my first Tournament played away from my home Club. The courts were in splendid trim, the weather was clement and I was happily watching a game whilst I awaited my turn to play. A stranger seated himself beside me and I naturally glanced his way with a welcoming nod. He seized the

opening. "Of course, it was nothing like this", he said. I nodded my agreement. He continued, "The weather was dreadful. On my honour, Sir, the conditions were vile. There was a high wind and the balls ran all over the place on what was no more than an apology for a proper surface. Quite impossible to hit in, you know - but I did so twice. And what was the result?"

He gave me a meaningful glare, intimating that he considered it his duty to answer his own question.

"I could not get on and he immediately took his two bisques to regain the innings. It was as a clear as a pikestaff that he had every intention of hogging the game, - just making a couple of hoops and laving up, knowing that even a first class player was powerless under the conditions. Sportsman? He had never heard of the word."

His indignation was rapidly rising.

"What made my blood boil," he continued, "was that he was so slow and kept going into a trance. He did everything wrong. After he ran the first hoop, his strikers ball came to rest within a foot or so of his partners ball and there was no rush. So, what did he do? He tranced and finally he took croquet without having made a roquet. 'Fault' I screamed. He stared at me blankly and looked appealingly at a referee who told him to replace the balls and carry on. Sometime later he played the wrong ball. I was confident now so I called for the Referee. It was the same fool Referee and after he had 'investigated the facts' - these were his his words - he ruled that he had played the right ball but taken croquet from the wrong ball. What's the difference is what I say?"

"All the time" continued 'he stranger, and now a note of anguish crept into his voice, "he was creeping slowly round and round. I repeat, he did everything wrong. He tripped over balls between strokes and I am certain he put them back into more favourable positions. Then he tried a new trick. He roqueted a ball, tranced and then roqueted it a second time instead of taking croquet. 'Fault' I shouted and who should appear on the scene but the same ignoramus. He let him carry on from the position of the first croquet. What can one do if the Referee will always give the grong answer?"

By now the stranger was quite overwhelmed with self pity.

"What could I do? He was nearly home. I kept telling myself that there was no justice in the world. But I am not the sort to give in. I kept on willing harder and harder that he would play the wrong ball." Finally he exclaimed with mounting excitement, "he did play the wrong ball. It was a perfect four-ball break. I went straight round to the peg. He never got in again."

In the meantime the stranger had undergone a complete transformation. His voice rang with confidence, his shoulders were squared and there was a savage gleam in his eye. I could see there was something more to come and I retreated slightly lest he gave me a dig in the pit of the stomach. However, he contented himself by adding for full measure;

"HE REALLY DID PLAY THE WRONG BALL"

I was somewhat shaken by all this so I asked my adversary before we started play what he knew of the matter

"Oh, so you have already been nobbled by Billings," he said with a chuckle. "This is his field day - the first day of the tournament - new faces - new audiences - he will tell them all. It's a let-off for the members who have to endure it endlessly.

"You see", he continued, "his opponent never did play the wrong ball. That is all made up. - and the game was never finished. What happened was that in the closing stages he played a desperation shot and hit in. It was a magnificent shot. Ther after all the excitement it was he who had played the wrong ball. Once again the same referee came on to the court to order him to quit the court, but the reverse happened. His terrible urge to chase and kill the referee gave way to his uncontrollable urge to continue to

play. It was physically impossible to restrain him. He went on playing by himself. Finally he ran off the court, shouting, 'I've won. I've won!' He's been mad ever since, but never violent. He tells the story night and day to screen his mind from the ugly facts of life."

I looked around and saw that he had pinioned the friend with whom I had travelled. At that moment the stranger was wallowing in self pity. As I continued to look I saw the gleam re-appear.

#### The Champion of Champions - A New Title

THIS TITLE from its inception will be associated with the name of Capt. H. G. Stoker, D. S. O., R. N., because the holder of the new title will become the holder of a new Trophy very generously presented by Mrs. Stoker in memory of her husband. The first holder will be the winner of a knock-out Tournament to be played at Hurlingham in July during the week of the Queen's visit: and it is intended that the semi-finals will be in course of play whilst Her Majesty is at the Club. The only players qualified to enter are the past winners of either the Open Championships or the President's Cup, and their names appear on page 12 of the last issue of "Croquet". The knock-out tournament which will be played during the Centenary Year will not be replayed in future years. However, the title will be at stake annually and the current holder will have every right to be regarded as currently supreme. Let it be assumed that 'Mr. A' becomes the title holder in 1967 and in 1968 he loses his title to 'Mr. B'. What will 'Mr. B' have to have achieved to gain the title?

(a) 'Mr.B' will have to have won both the Open Championships and the Presidents Cup and then have beaten 'Mr.A' in the challenge itself.

or

(b) 'Mr. B' will have to have won one of the above two titles; and then won the match against the other title holder and lastly won the challenge itself. If 'Mr. A' happens to be the other title holder for 1968 'Mr. B' will have to win two consecutive rubbers from 'Mr. A'

If 'Mr. A' wins both the relevant events in 1968, he will remain the holder without further play. It will be for the Council of the Croquet Season 1968-1969 to decide pursuant to Regulation 15 when and where the further matches shall be played. It has been suggested, however, that if only one rubber is necessary to find the title holder it should be played on the Saturday following the Presidents Cup; and if a second rubber is necessary it should be played on the following day, namely, the Sunday. Sunday play may still be a matter of controversy. Those who would oppose such a suggestion should bear in mind that week-end Tournaments have now become regular fixtures in the Croquet Calendar; that the likely contestants will all be at Hurlingham and that Sunday play will result in an economy both of time and expense. The many players in the croquet world who remember "Dacre" Stoker with admiration and affection should be glad that his memory is to be associated with the great challenge which is involved in the assault upon the new title.
